## **Minutes**

1) CORS was informed that Janne Lehmann Knudsen has left the Danish Medicines Agency and that she will step down as a member of the CORS SAB.

#### 2) Update from CORS

- **Biosimilars PhD project** (MDB). The recommendation from SAB (dd March 3, 2017) to grant the project 'Similar but not identical: the changing landscape of biosimilars from the regulatory, industry, professional, and patient perspectives' was approved by the SC (written procedure dd March 16, 2017) and CORS Partner LEO Pharma has committed to finance the project. The position will be announced soon.
  - Post meeting note: position was announced on June 20, 2017 with an application deadline of July 24, 2017.
- EMA Initiative on regulatory Science (MDB). The European Medicines Agency (EMA) has developed
  a framework to formalize, structure and further develop interactions with the academic community.
  This was communicated on the EMA website and presented at the DIA meeting in Glasgow (March
  2017). Marieke has met with Tony Humphreys (Head of Scientific Committees Regulatory Science

<u>Strategy</u> at EMA) to discuss the opportunities for collaboration between CORS and EMA, and will meet again on how to formalize this.

- **Spring symposium** (CH). The Copenhagen Centre for Regulatory Science and Denmark's Life Science Cluster, Biopeople, organised a symposium on research and education in regulatory science on 27 March 2017. The symposium had the pleasure of hosting a high-level delegation from Fudan University, Shanghai, China. With 46 participants in total (Academia n=23, Industry n=20, Regulatory Authorities n=3) and positive feedback, we look back to a successful meeting.
